GRAND JURY PRESENTMENTS BELL-FORSYTH JUDICIAL CIRCUIT MARCH TERM-2010 This Grand Jury met once each month during the four month term. The Grand Jury hereby respectfully submits the following presentments and recommendations to the Superior Court. A. PRESENTATION OF INDICTMENTS The District Attorney's Office presented 136 cases with 171 defendants for consideration. The Grand Jury returned 136 true bills and zero not guilty verdicts. B. REPORTS FROM THE CLERK OF COURT AND PROBATE COURT At the initial meeting in March, Greg Allen, the Clerk of Court, and Lynwood Jordan, Jr., Probate Court Judge, presented the group with reports outlining the office's activities and financial statements. C. VISIT TO FORSYTH COUNTY DETENTION CENTER During the April meeting, the Sheriff's Office provided lunch for the Grand Jury at the detention center. The Grand Jury finds that the current facility is extremely inadequate. The current jail was built in the 1970's and was intended to support a population of approximately 3,000 inmates. The current county population now exceeds 140,000 people. Because the jail cannot accommodate all county inmates, the Sheriff's Office is forced to house prisoners at other counties' jails, including Hall and Cherokee. This outsourcing costs Forsyth County taxpayers an estimated \$1.1 million annually. Our elected officers and county law enforcement officials are unable to provide the services and an outstanding job operating under the challenging circumstances that currently exist. This Grand Jury finds that the detention center is outdated, overpopulated and the County needs a facility that can handle current needs and future growth. D. MEETINGS IN FORSYTH COUNTY COURTHOUSE Over a period of four months, the Grand Jury met in the County Courthouse. It houses the State and Superior Courts, as well as the Clerk of Court and District Attorney's and Solicitor's Offices. The Grand Jury finds that this facility is also overpopulated and inadequate to serve the needs of court services and law enforcement. For example, the water is not suitable to drink. There are several offices that have had to move operations off site to temporary trailers and other vacated
