Special Olympics Bocce Invitational a success







Bishop, along with the Terrell running backs showed him plenty of speed with six carries of 30 yards or more.

Terrell kicked off to begin the game. The Blazers ran three plays and punted. Terrell went on offense on the Blazers' 49 yard line. Two rushes and they were on the scoreboard; the 2 point conversion was good and the Green Wave was up by 8 with only two minutes off the clock. The Blazers' offense was 3 and punt again. Terrell started on the 50 yard line this time. It appeared they would need only one play to get on the board again, but the runner was pushed out of bounds on the one yard line, It

took them two more plays to get into the end zone. The PAT failed, making the score 14 - 0 midway through the first quarter.

Principally on the running of Max Deen, the Blazers moved from their 35 yard line to Terrell's 35 before giving up the ball. The Blazers' on-side kick to begin the second half resulted in Terrell starting on their 45 yard line. On the first play, Bishop carried for a TD. The PAT was no good, and Terrell led 34 - 0 after one play in the second half. Terrell forced a punt from the Blazers' 49, and a high snap resulted in Terrell recovering on the 24 yard line. A TD was called back for a penalty on the Green Wave's first play. The Blazers held for three downs, then Zeke Deen intercepted a pass in the end-zone to stop that scoring opportunity.

A Blazer fumble gave Terrell the ball on the 10, but the Blazers held once again and took possession on about their 6 yard line. The Blazers moved into Green Wave territory, again principally on the running of Max Deen, before being forced to punt. Terrell started from their 10 and in three plays were on the board again, to make the final score 40 - 0.
