The project is located in the City of Milton just west of the community of Crabapple, and Land lots 1098, 1099, 1134-1136, 1169, 1170, of the 2nd District and 2nd Section of Fulton County.

The project consists of adding left turn lanes on SR 372 (Crabapple Road/Birmingham Highway) and Broadwell Road; improving the typical section and alignment of the existing local roads McFarlin Lane/Parkstead Lane/Branyan Trail from the existing intersection of McFarlin Lane with SR 372 (Birmingham Highway) to the end of existing Branyan Trail; and extending the Branyan Trail approximately 500 feet, of new location roadway, to intersect with SR 372 (Crabapple Road) at Crabapple Chase Drive. Two single lane roundabouts are also proposed; one at SR 372 (Crabapple Road) and Crabapple Chase Drive, and the other at SR 372 (Birmingham Highway) and McFarlin Lane.
