Notice is hereby given in compliance with Georgia Code 22-2-109 and 32-3-5 that the Georgia Department of Transportation has approved the Location and Design of this project.

The date of location and design approval is: July 15, 2014.

The proposed project would construct a two lane urban roadway, beginning approximately 430 feet north of the intersection with SR 10 / US 78 and Hewatt Road. The project would proceed east, following the existing funeral home driveway for 0.16 miles, before continuing on the new roadway alignment for 0.16 miles to Parkwood Road. After crossing Parkwood Road, the project continues east on the new roadway alignment for 0.15 miles to Westside Circle and then follows the existing Westside Circle for 0.05 miles. The proposed project then proceeds north on the new alignment and turns east to follow the residential property line along Birchwood Trail before tying into the existing Elmwood Circle and ending at Britt Drive. The proposed length of this project is 0.95 miles. In addition, the existing vertical profile on Parkwood Road will be modified to provide adequate sight distance at the proposed connector street intersection with Parkwood Road. The construction length along Parkwood Road is 1,210 ft. and will require a detour during construction. The typical section for the proposed connector street will include 11 ft. wide lanes with curb and gutter and a 5 ft. wide sidewalk with a 2 ft. wide grass strip on the south side of the connector street. The typical section will also include a 10 ft. high visual screening wall that will be located on the north side of the connector street located approximately 125 ft. east of the Hewatt Road intersection to 40 ft. west of the Parkwood Road intersection. The proposed project is located entirely in Gwinnett County within Land District 6, specifically within land lots 52.53 and 67.

The proposed project then proceeds north on the new alignment and turns east to follow the residential property line along Birchwood Trail before tying into the existing Elmwood Circle and ending at Britt Drive. The proposed length of this project is 0.95 miles. In addition, the existing vertical curve on Parkwood Road will be modified to provide adequate sight distance at the proposed connector street intersection with Parkwood Road. The construction length along Parkwood Road is 1,210 ft. and will require a detour during construction.

PUBLIC HEARINGS

The typical section for the proposed connector street will include 11 ft. wide lanes with curb and gutter and a 5 ft. wide sidewalk with a 2 ft. wide grass strip only on the south side of the connector street. The typical section will also include a 10 ft. high visual screening wall that will be located on the north side of the connector street located approximately 125 ft. east of the Hewitt Road intersection to 40 ft. west of the Parkwood Road intersection. The proposed project is located entirely in Gwinnett County within Land District 6, specifically within land lots 52, 53 and 67.
