Georgia Department of Transportation Proposed Bridge Replacement over Little River on SR 47 Project BRST0-0076-01 (036) Columbia - Lincoln P.I. No. 232310

The Georgia Department of Transportation (GDOT) is issuing this public notice concerning Project BRST0-0076-01(036), PI No. 232310 in Columbia - Lincoln County which proposes the replacement of the functionally obsolete and structurally deficient bridge on State Route 47 over the Little River (J. Strom Thurmond Lake). The project would begin at approximately Mile Post (MP) 16.25 in Lincoln County and end at approximately MP 0.85 in Columbia County. The new bridge would be constructed on new alignment approximately 31 feet to 45 feet to the east of the existing bridge. Traffic would be maintained on the existing alignment during construction. Approximately 8 feet to 35 feet wide permanent easements would be required from the U.S. Army Corps of Engineers for the construction and maintenance of slopes. Additional right-of-way would not be required for this project. The posted and design speeds are 55 miles per hour. The total project length would be approximately 1.34 miles.

The project will require approximately 4,727 acres of permanent easement and 0.342 acres of temporary easement for construction purposes. These right-of-way and the time period the area will be under construction may impact public access to land and water on the J. Strom Thurmond Lake. Also, there is an existing roadside parking area that provides access to bank fishing in Columbia County, on which GDOT has agreed to place an aggregate surface and enclose the area with a guardrail. The parking improvements will enhance safety and parking for bank fishermen. The raised height of the proposed new bridge will significantly improve access for boaters with larger vessels that are currently unable to pass under the existing structure. These improvements will mitigate impacts to recreation from construction and easements needed for the bridge project.

As a recreation facility, the J. Strom Thurmond Lake is afforded special protections under Section 4(f) of the Department of Transportation Act (recodified in 49 U.S.C. 303 and 23 U.S.C 138). Under the provisions of Section 4(f), if the proposed project would result in adverse effects to a park or recreation facility, the transportation agency must conduct an evaluation to demonstrate that there is no prudent and feasible alternative to the use of the 4(f) property. Because this evaluation can be expensive and potentially result in project delays, an exemption is provided in cases where the official with jurisdiction over the park or recreation area concurs in a determination that the impacts are not adverse. This concurrence enables FHWA to make a de minimis (minimal impact) finding, which satisfies the requirements of Section (4) and precludes the need for a Section 4(f) Evaluation. The U.S. Army Corps of Engineers has concurred that the proposed project would not adversely affect the activities, features, and attributes of the recreational facility for protection under Section 4(f).
